Biographies

Mr. Terence F. Mahony, Chairman Platinum Advisory Intl. Inc.

Terence F. Mahony, 65, has over 40 years of professional experience in investment management and financial services. After 20 years in Institutional Sales at White Weld and Paine Webber in Geneva and Hong Kong (1970-1990), Mr. Mahony was recruited by Baring International Investment Management in Boston to serve as Director and Chief Investment Officer of Latin America, where he launched the highly successful Baring Puma Latin America Fund. In 1993 he joined HSBC Asset Management as Chief Investment Officer for Global Emerging Markets and Member of the Global Asset Allocation Committee, and launched HSBC's first Global Emerging Markets fund. From 1996 to 1999 Mr. Mahony served as Trust Company of the West's Managing Director for Emerging Markets Equities, Chief Investment Officer of Global Emerging Markets, and President of TCW Asia Ltd., overseeing up to \$2.2 billion assets under management. Mr. Mahony currently serves as IMS (Investment Manager Selection)'s Director and Investment Committee member and Chairman of Platinum Advisory International Inc. Mr. Mahony holds a MBA (INSEAD) and a BA (Oxford).

Mr. Stephen G. Simmons, Managing Partner Leopard Cambodia Fund

Stephen G. Simmons, 50, spent 11 years with CLSA Securities in Hong Kong, Bangkok, and London, holding managerial positions such as Head of Thailand Sales, Head of the Thailand, Indonesia, and Philippines offices, Head of Eastern Europe, Middle East & Africa Sales in London, and Head of South East Asia Sales in London. Mr. Simmons subsequently founded and managed Invicta Property Partnership LLP, which invested in more than 25 properties in England. Mr. Simmons graduated from Sandhurst and served for 17 years in the British Army, reaching the rank of Major.
